## Virtual Play Date Sweepstakes Official Rules

- 1. Eligibility: Virtual Play Date Sweepstakes (the "Sweepstakes") is open only to legal residents of the forty nine (49) United States (excludes Rhode Island) and the District of Columbia who are at least eighteen (18) years old at the time of entry. **5. How to Enter:** During the Promotion Period, visit <a href="www.simon.com/Disney">www.simon.com/Disney</a> follow the directions to provide your name and email address. You will automatically receive one (1) Sweepstakes entry into the applicable Monthly Entry Period associated with the time and data of your registration. By completing the registration form, you are also agreeing to receive email-marketing messages from Simon Property Group and ABC Cable Networks Group. You may withdraw your consent at any time without affecting your Sweepstakes entry.

<u>Limit</u>: Each entrant may enter one (1) time each Monthly Entry Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's entry and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration or entry, the authorized account holder of the email address used to register will be deemed the entrant. Winner Determination and Verification:** Administrator is an independent judging organization whose decisions as to the administration and operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes. Each potential winner will be notified by email and will be required to provide their name, home mailing address, date of birth, and email address to confirm eligibility and for prize fulfilment purposes within five (5) days of the date notice or attempted notice is sent, to claim the prize. If the potential winner cannot be contacted, fails to provide the requested information within the required time period, or prize is returned as undeliverable, potential winner forfeits prize.
